COURSES AND BIRDS

ALL STAKES ARE SINGLE COURSE WITHOUT A BIRD FIELD. QUAIL RELEASED IN ALL STAKES EXCEPT OPEN PUPPY. NO BIRDS WILL BE RELEASED IN THE OPEN PUPPY STAKE. A BLANK CARTRIDGE WILL BE FIRED IN THE OPEN PUPPY STAKE.

NO OPEN BARRELS ALLOWED. HORSEBACK HANDLING ALLOWED IN ALL STAKES EXCEPT AMATEUR WALKING GUN DOG WHICH IS WALKING ONLY.

Tracking collars are allowed in all stakes, in strict accordance with AKC regulations governing their use. "Use of AKC approved tracking collars is permitted."

**Bitches in season may compete in the final braces of the Amateur Gun Dog.
Only AKC approved tracking & GPS collar models will be allowed.**

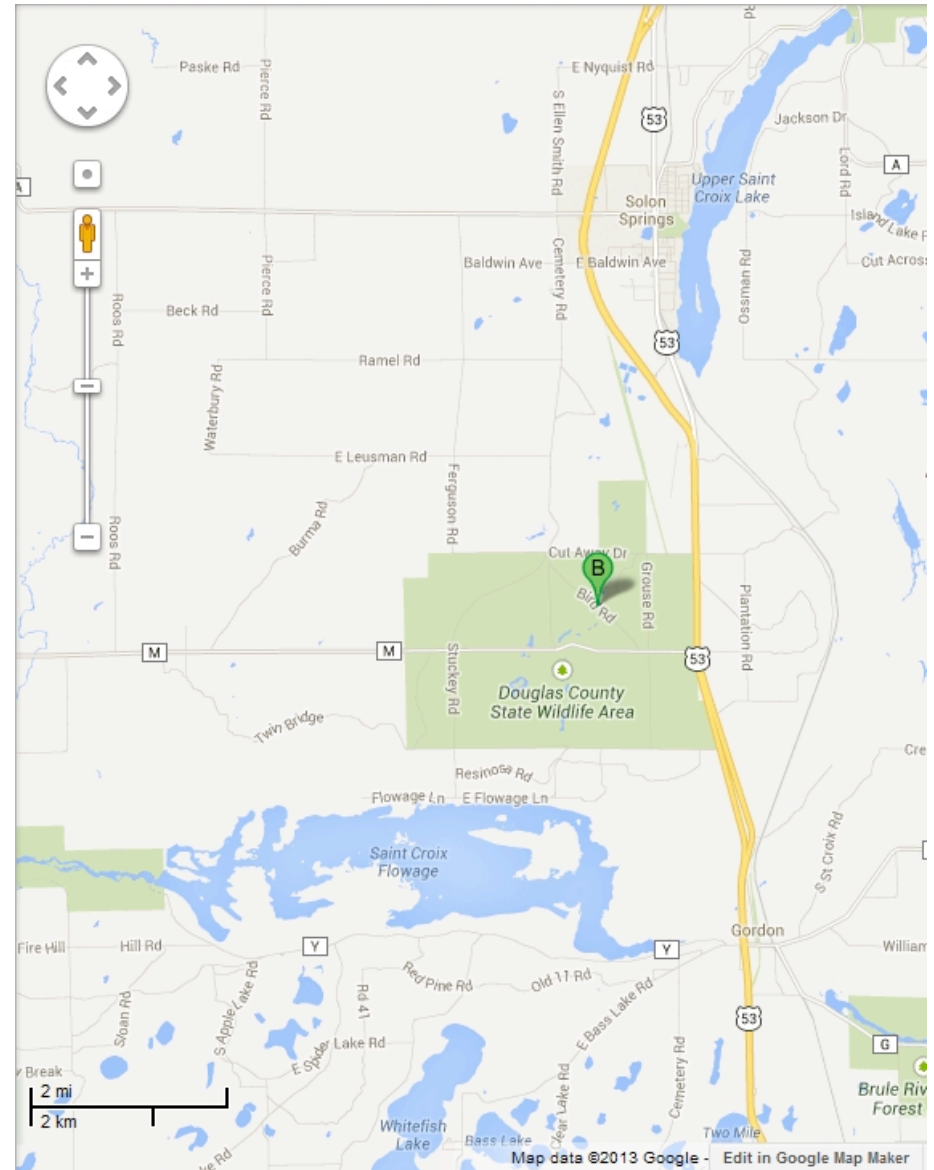
